
please share with us what you are doing in retirement and your important dates as well.

I. The 2015 Annual Reunion - Monterey, California - October 12-15, 2015



This year's annual reunion will be held at The Monterey Plaza Hotel and Spa in Monterey, California, October 12-15. (The hotel website is

<u>www.montereyplazahotel.com</u>. The RMC website <u>www.nylrmc.org</u> also has a link to the hotel's website.) The Monterey Plaza has been named one of the Top 25 hotels in the entire United States so we're looking forward to a great program at a superb location.

It's time to make room reservations for the 2015 RMC meeting and <u>you are urged to do</u> <u>so as soon as possible.</u> To reserve your hotel room, please call the Monterey Plaza <u>directly</u> at <u>1-(800)-334-3999</u> for arrival on Monday, 10/12, with checkout on Thursday, 10/15. (RMC Board members arrive Sunday, 10/11, for pre-meeting and set-up.) <u>Be sure to identify yourself as being with the "RMC" of New York Life Annual Meeting 2015 to get the group rate.</u>

The deadline to make your reservation is Sunday, September 20th at 4:00 PM to assure getting a room. We have group room rates in four (4) different categories:

Inland View - \$199 @ night (limited availability of this room type);

Partial Ocean View - \$289 @ night

Ocean View - \$319 @ night

Ocean View Balcony - \$399 @ night

In addition, there is a \$27 per night Resort Fee which includes 24 hour valet parking, WiFi, spa use (inc. fitness center and whirlpool), daily paper, and unlimited local phone calls. RMC members and their guests will also be entitled to a 20% discount on spa services. The hotel is guaranteeing the special room rates for one extra night only at the end of the meeting (the night of Thursday, October 15). If you do extend your hotel stay for that one extra night, you must mention this when you make your reservation in order to receive the special rate.

IMPORTANT NOTE: Spouses and significant others are welcome and urged to come and share in the RMC Annual Meeting.

Other Meeting Information:

Weather – Monterey is described as having a Mediterranean climate. In October, temperatures average a high of about 67 degrees and a low in the mid-50's. Precipitation averages less than an inch in the month.

Air Travel – Although there is daily non-stop service into Monterey Regional Airport from Denver, Las Vegas, Los Angeles, Phoenix, San Diego, San Jose and San Francisco (service by American, Delta, United, Alaska and US Airways), <u>RMC members are urged to consider flying into either San Francisco or San Jose, then use the following shuttle service from SFO or SJC which will take you right to the hotel. (It's about a 90 minute drive.)</u>

For full information, go to www.montereyairbus.com or call (831) 373-7777.

If there are four of you traveling together and you do not choose to rent a car, limo service can be arranged and the cost will be less than taking the shuttle service. Let us know when you have made your travel arrangements, and we will organize a limo for your group. Auto Travel – The hotel website also has driving directions to get to the hotel from Monterey Regional, San Francisco International or San Jose International Airports.

Business Program – Arrival, registration and a Welcome Dinner will occur on Monday, October 12. Business sessions will be conducted on Tuesday and Wednesday mornings, and generally include topics of interest and guest speakers on "The State of the Company," NYL products and programs, Retiree benefits, Health and Wellness, The American College Intern Program, the MDRT Scholarship Program, local sites and history of the meeting location, etc. Departure will be on Thursday morning, October 15. Specific details of this year's business program will be provided when finalized.

Attire – "Business casual" (slacks & collared shirts) is recommended for the business sessions; tie & jacket or cocktail dress is optional for the planned dinners.

Special Activities – We have a wonderful program of activities outside of the business sessions to make your visit to Monterey special. There will be three (3) different optional tours during the RMC program and each will be offered on both Day One (Tuesday) and Day Two (Wednesday) of the meeting. Included will be:

- 1) Motor Coach Tour 17 Mile Drive culminating with bag pipers at Spanish Bay, Pebble Beach. There is a maximum of 40 people for this tour each day.
- 2)Behind the Scenes Tour See the Monterey Bay Aquarium like you never have before. This is an "insider's tour" where you'll discover what it takes to run a world-class

aquarium, conduct fascinating research projects, and how they feed over 10,000 animals.
3) Carmel Wine Walk By-The-Sea – Guests will have their choice of any 9 of 14 tasting rooms which are on the tour. The Wine Walk is a self-paced, self-guided stroll to the tasting rooms which are all within a few blocks of each other and offer the opportunity to savor superior still and sparkling wines.

Dinner will follow each tour on both nights. The first night will be a dinearound; the second night will be a group dinner for all to gather together. Full details on the optional tours will be available later on the RMC website with the meeting registration information. Meeting Registration – The program for this year's RMC Meeting is still being finalized – so the Registration form is not ready to be opened on the RMC website. Everyone will be advised with instructions when it is ready so delegates can proceed with registering. ***IMPORTANT: REGISTER FOR THE HOTEL NOW (SEE PAGES 1-2);**** (Register for the meeting later when the form is ready and you are advised to do so.)

SPECIAL NOTE: We will offer a pre-RMC Meeting wine tour of California's Amador Region, with arrival on October 8th and departure on October 10th. Attendees can stay over in Sutter Creek, take a leisurely drive to Monterey or stay in San Francisco until the RMC arrival date of October 12th in Monterey (standard hotel rates apply).

"Wine on Main in Historic Sutter Creek" is a journey through California's rich and intriguing history while tasting the finest wines from the region. It features 9 wine tasting rooms, all located within walking distance of each other in charming Old Town Sutter Creek. (One of the stops is at Michael and Charlie's very own BellaGrace tasting room.) We will also have a tour of the historic Shenandoah Valley of California with stops at various award winning wineries culminating in a private tour of BellaGrace Vineyards winery, vineyards and wine cave with a casual dinner at the property. RMC members would fly into Sacramento, rent a car and drive about an hour and a half to the Amador Region. Afterward, the drive to Monterey for the RMC meeting would be about 3 hours. 
